### **Enhanced Market Access for LDCs**

The Istanbul Programme of Action calls for a “timely implementation of duty and quota free market access, on a lasting basis for all LDCs” in line with the Hong Kong Ministerial Declaration, and “the abolition or reduction of arbitrary or unjustified trade barriers.” Many countries have expressed their support to give LDCs unrestricted market access to all products but the Istanbul conference as well as the Doha Round negotiations still fall short of a more meaningful delivery.

During the Istanbul conference, the EU presented the reform of the generalized system of preferences (GSP) to the LDC community. This reform aims at helping developing and least developed countries to export their products easier to the European Union. The session will assess the proposal and provide a floor for the discussants to give their perspectives on it.
